Division I. Water Court Resume':

Julesburg Recharge Project:

Charles Julius remains the only well owner who has yet to pay their pumping bill from last year.

Heyborne Recharge Project:

The recharge site has been shut down since the beginning of June. Technician Fleharty noted that Blochowitz Ditching will be cleaning the site in preparation for fall recharge.

# **LEGAL REPORT:**

Counsel Donovan noted in his report that no statements of opposition were filed on the Lechman diligence application. Counsel Donovan will also sign and send back to John Buchanan the stipulation on the Harmony diligence application.

- The Colorado Water Congress Summer Convention will be held August 20-22 in Colorado Springs.
- ✓ South Platte Water Related Activities Program (SPWRAP)
  - Manager Frank said that the Tamarack/Peterson Ditch Interaction committee has
    evolved into more of an operations committee. Committee members include
    Manager Frank, Rich Belt, Ryan VanPelt, and Jon Altenhofen. The committee is
    recommending that the Tamarack recharge wells begin pumping later in
    November instead of the 1<sup>st</sup> of November and also start pumping the furthest
    wells first with the closest wells to the river begin pumping last.
- ✓ Platte Valley Water Partnership -
  - Manager Frank said that LSPWCD staff has been actively involved in meetings and tours this spring and summer which he felt had been very productive.
- ✓ Donation
  - <u>Director Coyne made the motion to donate \$300.00 towards a PVWP fund to assist Mark McClean with meal expenses, Director Poitz seconded the motion which passed unanimously.</u>
