APPROVAL OF THE NOVEMBER 14, 2023 BOARD MINUTES:

<u>Director Kembel made the motion to approve the November 14, 2023 Minutes as presented.</u>

FINANCE REPORT:

Director Coyne presented the finance report for the month of November. <u>Director Coyne made</u> the motion to approve payment of District checks 16947 – 16974 as well as Julesburg Recharge check1220. <u>Director Kendrick seconded</u>. <u>Motion carried</u>.

RIVER MONITORING:

Division I Water Court Resume':

No statements will be filed from the October Water Court Resume.'

Julesburg Recharge Project:

Manager Frank stated that he will begin drafting the year-end billing for the 2023 pumping season but that overall, it was a good water year.

Heyborne Recharge Project:

Manager Frank noted that the floating pump is not able to maintain a constant pumping rate. Staff continues to trouble shoot the issue to come up with the best solution.

LEGAL REPORT:

Manager Frank reviewed the Court Order following the trial in the ACWWA/ECCV change case of Fort Morgan shares.

As reported last month, Lower filed a statement of opposition on case #23CW310 because Harmony did not correct values in their accounting and overstated the amount of water diverted for recharge during their diligence period. Counsel Donovan noted in his attorney's report and that Harmony was asked to provide the Court with proof of the claimed absolute volume.

Manager Frank reminded the board that the Appeals Court would be hearing the District's Mill Levy case later today.

PRESIDENT'S REPORT:

President Fritzler appointed Director Kendrick as the nominating officer for 2024. The board will vote on the 2024 slate of officers at the January board meeting.

MANAGER'S REPORT:

Legislative Matters:

- ➤ WRASP -
 - <u>Director Kembel made the motion that the District contribute \$4,000 to WRASP for 2024. Director Kendrick seconded the motion. Motion carried.</u>

General Matters:

- > Assessed Valuations -
 - Due to the changes in the 2023 State Assessed Valuations for budget year 2024, Manager Frank expressed the need to have a full board meeting in January so that the board could vote on the Resolution to Set the Mill Levy and the Resolution to Appropriate Sums of Money. The January board meeting will be held on the 9th with Certification of Taxes due to the counties by January 10th.
- ➤ 2024 Salary Increase
 - <u>Director Kendrick made the motion that Manager Frank and Technician Fleharty receive a 5% increase in salary, with Technician Brownell receiving a 15% increase in his salary due to his extra workload. Director Manuello seconded the motion. Motion carried.</u>
- Perkins County Canal
 - There will be a Townhall Meeting regarding the Perkins County Canal on December 19th at the Keith County Fairgrounds Exhibit Hall in Ogallala from 11:00 am – 1:30 pm.
- > South Platte Water Related Activities Program -
 - Manager Frank reminded the directors that SPWRAP will be holding their 1st Quarter Board meeting at the new District office (615 South 10th Avenue, Sterling, CO) on February 15th at 9:00 a.m.
- Platte Valley Water Partnership
 - Meetings are scheduled with the Lower Platte & Beaver board of directors as well as Colorado Parks & Wildlife staff to discuss the recent PVWP amendment.
- Cyber Security Insurance
 - <u>Director Kendrick made the motion to approve the bid from Hix Insurance for cyber security insurance at approximately \$1,519.00</u>. <u>Director Patterson seconded</u>. Motion carried.
